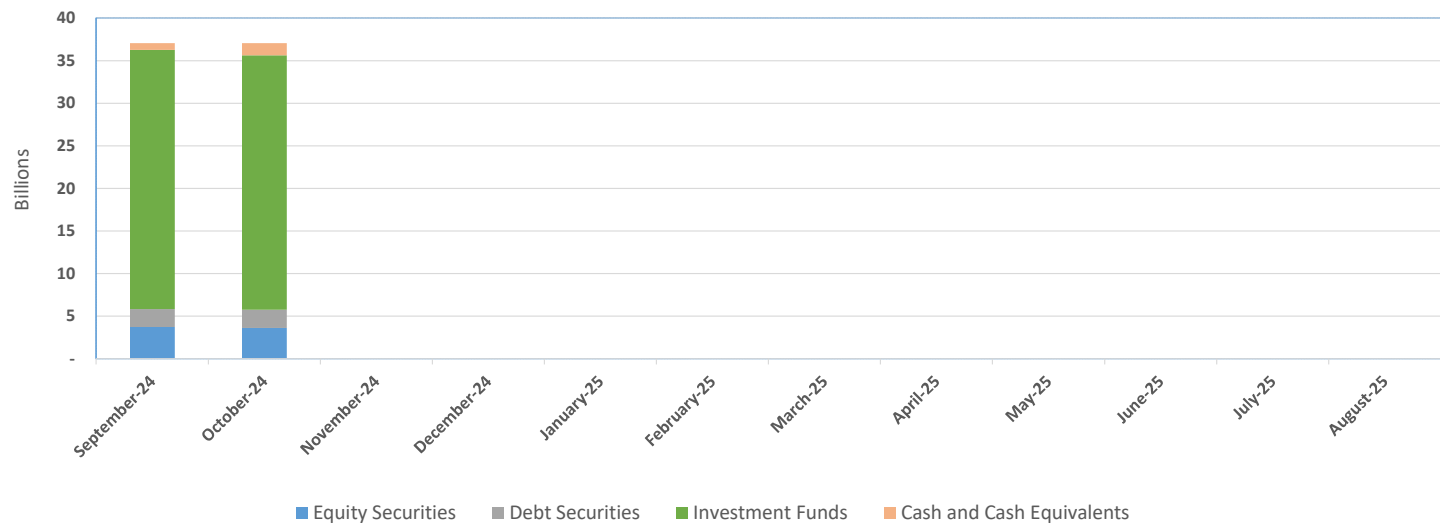
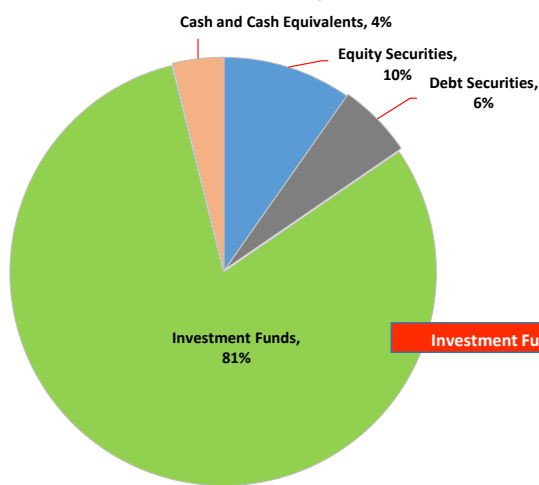

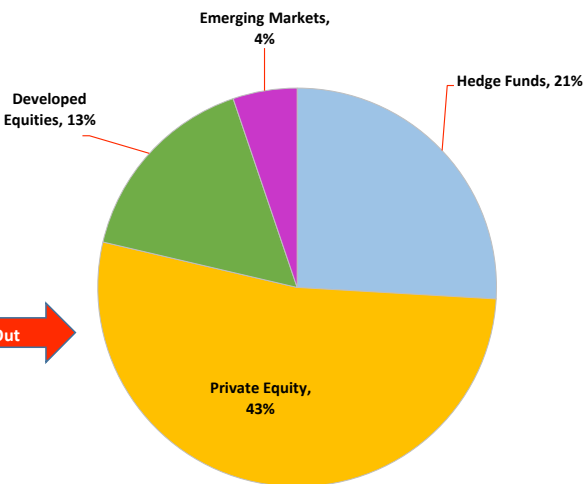
Investment Portfolio - FY 2025



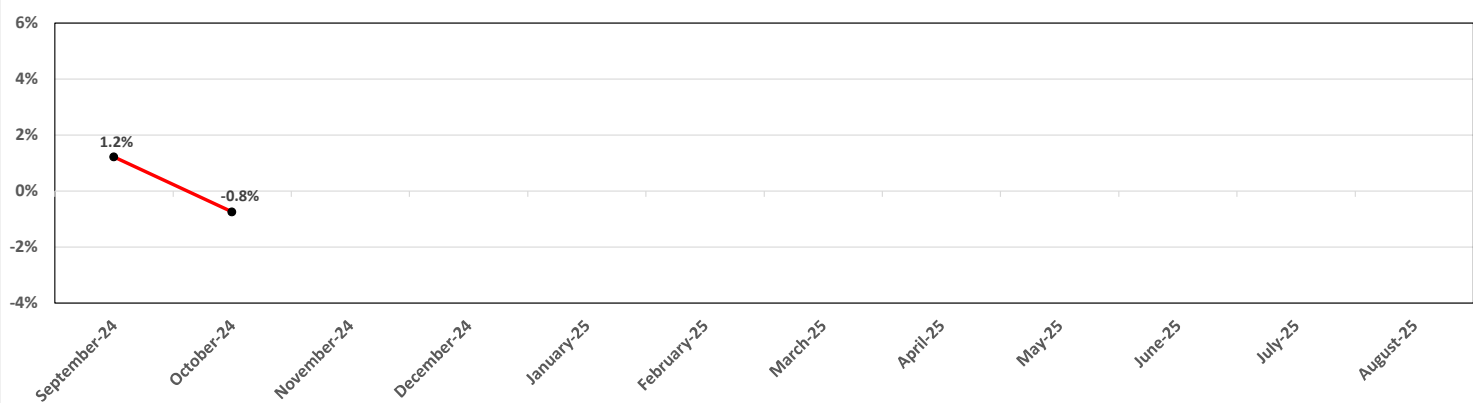
Investment Portfolio as of September 2024
